**FEE: \$60.00 per space for craft vendors and artisans. Please note that if fee is received before April 30, 2014, it will be \$50.00, per space.**

**FEE: \$85.00 per space for food vendors. Please note that if fee is received before April 30, 2014, it will be \$75.00, per space.**

**FEE: \$300.00 for each Pavilion food vendors.**

**FEE: \$15.00 for each Flea Market/Yard Sale space for the two (2) days.**

**FEE: NON-PROFIT ORGANIZATIONS, PLEASE CALL FOR VENDOR FEE.**

If electricity and/or water are needed for food/craft vendors the fee will be \$15.00 for the event. Must provide own power cord.

All applications must be received by 7/1/2014. After July 1, 2014, spaces will be available on a **FIRST COME, FIRST SERVED BASIS. NO EXCEPTIONS.**

ALL VENDORS MUST SET UP DISPLAYS DURING SET UP TIMES ON FRIDAY EVENING OR SATURDAY MORNING BUT NO VENDOR WILL BE PERMITTED TO SET UP AFTER 8:30 A.M. ON SATURDAY AND SUNDAY. NO VENDOR WILL BE PERMITTED TO TEAR DOWN UNTIL 5:00 on SUNDAY.

Trash will be your responsibility at the end of each day. Trash containers will be located throughout the town for your convenience. Please leave the area as clean as you found it. Food vendors are responsible for taking grease with them.

All spaces will be marked. No vendors' vehicles will be permitted in vendor area when the streets are closed for the show. Off street parking will be designated for vendors' vehicle parking. All vendors must supply all necessary equipment such as tables, canopies, chairs, etc.

To facilitate traffic flow at the end of each day, all vendors are requested to have their wares packed and ready for loading before their vehicle arrives to load.

No exhibitor may sell their assigned space to another craft person or share their booth with any non-applicant.

If there is a vendor appreciation event, food and craft vendors will receive two (2) vouchers per space, and flea market vendors will receive one (1) voucher per space.

Applications are subject to the final approval of the C & O Canal Days Committee. No refunds for cancellations of space after July 15, 2014, unless for legitimate reason, such as death or illness. No funds for no show. The Town of Williamsport assumes no responsibility for accidents or damages to exhibits or persons.
